

**WRD MIIP Canal Improvement Works –
Details to be incorporated in the DPR Proposal:**

2. Project Description in detail including salient features clearly indicating the year of commencement of the project (headworks, canal works, distribution network) and year of completion of the project.
3. Status of Water User Associations (WUAs) and details of handing over of the Irrigation Management Systems to WUA.
